Subject: Appeal for U.S. Support in Safeguarding Democracy in the Republic of Moldova

Mr. President,

Modern Democratic Party of Moldova (PDMM) is thrilled to express its gratitude for the continuous and important support provided by U.S. Government to Republic of Moldova and to Moldovan's people. U.S. Government substantially contributed to profound economic growth, realization of major infrastructure projects and strengthening rule of law and democracy.

Unfortunately, due to recent developments in Republic of Moldova, as per Democracy Index (The Economist Intelligence Unit Limited 2025) Moldovan score fell by 0,46 points, putting it just below the threshold to qualify as "flawed democracy", putting it just next to hybrid regimes.

On September 28, 2025, the people of Moldova will carry out a fundamental exercise for democracy and decide their own destiny, by holding parliamentary elections, the supreme legislative forum and the most representative institution. It is of utmost important this exercise to be free and guaranteed to all persons. It is a chance for the Republic of Moldova to form a parliament that will represent all citizens and that will fight for the interests of all, and for the removal of the vices and authoritarian dispositions that have become deeply rooted in the already robust structure of the power hierarchy in Chisinau.

Unfortunately, representatives of the current government commit several serious offenses in order to preserve their power, creating barriers and persecuting political competitors, including their family members, their business and private activities, even applying physical violence, falsifying documents, criminal files, etc.


In relation to PDMM, the Moldovan authorities have started the entire power machine, including the propaganda and persecution machine, the intelligence services, in order not to admit it into the parliamentary race. Special insistence and pressure is placed on Vladimir Cebotari, the founder of the party.

Mr. President, you are a leader whose words resonate far beyond America's borders. We respectfully appeal for your support in drawing attention to these abuses. Your voice could help ensure that the Moldovan people are allowed to choose their representatives freely, without unlawful interference or fear of reprisal.

Your support at this critical moment would send a strong signal in defense of democracy and human rights in Moldova.
